

165-X-23-.01 Match Permits

165-X-23-.02 Show Date Requests

165-X-23-.01 Match Permits

1. Match permits. Match, contest, and/or exhibition permits will be determined and issued at the discretion of the Commission's executive director upon receipt, review, and approval of all materials required in the Show Date Request.
 - (a) Matchmaker licensing will be determined at the discretion of the sanctioning Commissions.
 - (b) A match permit fee will be calculated by the Commission. The match permit fee shall be calculated at five percent (5%) of the gross proceeds from ticket sales to the boxing match, contest, or exhibition, exclusive of any federal taxes.

165-X-23-.02 Show Date Request/Event Permit

1. Show dates. Show dates for any match, contest, or exhibition to be sanctioned by a licensed sanctioning organization shall be submitted by the event promoter in writing to the Commission's executive director no less than thirty (30) days prior to a scheduled event. Show date notifications shall include:

- (a) Date of the Event
- (b) Location of the Event (full street address and city)
- (c) Promoters Name and contact information
- (d) Promotional Company Name
- (e) Event Status (Professional/Amateur/Pro AM)
- (f) Proposed Licensed Sanctioning Organization or Body (if applicable).

A \$150 Event Permit Fee should be included in the show date request.
