NOTICE OF INTENDED ACTION

RULE NUMBER: 270-X-4.08

TITLE OF RULE: Advertising.

- (1) A dentist shall not make or cause to be made a false communication about the dentist or the dentist's services. A communication is false if it contains a material misrepresentation of fact or law.
- (2) A communication is defined as information in any manner or medium designed or intended to attract public attention to the dentist or his/her practice and shall include any "advertisement" as that term is defined in <u>Code of Ala. 1975</u>, <u>Code of Alabama (1975)</u>, §34-9-19.
- (3) Any/all advertisements/communications for a dental practice must include one or more of the dentist's/dentists' names within the advertised practice.
