270-X-4.10 Registration of a 501(c)(3) Dental Clinic.

Every 501(c)(3) nonprofit entity that operates one or more dental clinics must register with the Board on or before the 1st day of October of each year to obtain a dental annual registration from the Board. Registration shall consist of completing the dental annual registration form and payment of the dental annual registration fee for each clinic operated by the 501(c)(3) entity. The dental annual registration fee shall be set by the Board as per Code of Alabama (1975) §34-9-16. The registration shall be renewed on an annual basis. The information required on the registration form shall be the following:

- 1. Name, address, phone number and after hours contact information of the 501(c)(3) entity.
- 2. The name and contact information of the Chief of Dental Services of the 501(c)(3) entity if the 501(c)(3) entity is operating multiple clinics.
- 3. Name, address, phone number and after hours contact information for each clinic operated by the 501(c)(3) entity.
- 4. A list of all licensed dentists and hygienists that work for the 501(c)(3) entity. All licensees must have all applicable licenses and registrations as required by this chapter. Any changes to the employment/volunteer status of these licensees must be reported to the Board within thirty (30) days.
- 5. A copy of the Articles of Incorporation of the 501(c)(3) entity.
- 6. A valid copy of the IRS Determination Letter of the 501(c)(3) entity.
