270-X-5.09 Non-Disciplinary Administrative Penalties.

Any <u>dentist/dental hygienist_licensee</u> who is found to be in violation of the following requirements of the Alabama Dental Practice Act shall have imposed a non-disciplinary administrative penalty in the amount set forth below:

- (1) As to dentists only, failing to renew their DEA registration within one (1) year of the expiration thereof.
- (2) As to dentists only, any practice owner who allows a dentist/dental hygienist licensee to practice up to thirty (30) days without an eurrent-annual registration permit.
- (3) As to dentists only, by failing to comply with the provisions of <u>Code of Alabama</u> (1975), § 34-9-15.1.
- (4) Failing to timely renew any license or permit required pursuant to the Alabama Dental Practice Act and performing activities which require the applicable license or permit <u>for up to thirty (30) days</u> during the time the same was expired.
- (5) Failing to comply with the provisions of Board Rule 270-X-4.04. In addition to the applicable penalty, the licensee shall be required to make up the number of deficient hours by December thirty-first (31st) of the following renewal period.
- (6) The penalty for a violation by dentists shall be up to five hundred dollars and 00/100 (\$500.00).
- (7) The penalty for a violation by <u>licensed dental auxiliary</u> dental hygienists shall be up to two hundred fifty dollars and 00/100 (\$250.00).
- (8) Failure to pay the penalty within the time prescribed by the Board, unless otherwise notified, will result in disciplinary action per 34-9-18(a).
- (9) A dentist/dental hygienist <u>licensee</u> shall not qualify for the non-disciplinary administrative penalty referenced above for more than two (2) one (1) violations occurring within five (5) years of any prior application of this rule.
