- (1) The Alabama Criminal Justice Information Center Commission shall be composed of two sections. The voting section will include: the attorney general, the chairman of the Pardons and Paroles Board, the commissioner of the Department of Corrections, the president of the Alabama Sheriffs' Association, the director of the Department of Public Safety, the president of the Alabama Association of Chiefs of Police, the director of the Alabama Department of Economic and Community Affairs, the president of the District Attorneys' Association, the president of the Circuit Clerks' Association, the Chief Justice of the Alabama Supreme Court, the president of the Alabama Association of District Judges, the president of the Alabama Association of Circuit Judges, the Governor's coordinator of Alabama Highway and Traffic Safety, and the director of the Information Services Division of the Alabama Department of Finance.
- The advisory section will include: the presiding officer of the Alabama Senate, the speaker of the House of Representatives, the president of the Association of County Commissions of Alabama, the president of the Alabama League of Municipalities, the director of the Administrative Office of Courts, and a citizen of the State of Alabama to be appointed by the Governor.
- Members shall have authority to select a designee based upon (3) qualifications and with a view of continuity of representation and attendance at the Commission meetings. No person or individual shall continue to serve on the Alabama Criminal Justice Information Center Commission when he no longer officially represents the function or serves in the capacity enumerated herein as a member to which he was elected or appointed.
- Members of the Commission and their designees shall serve without compensation, except payment of their expenses may be paid in accordance with the applicable state travel regulations.
