660-3-12-.07 Release of Lien/Levy.

The lien/levy will be released if it is determined that: A Notice of Release of Lien shall be sent by the state IV-D agency to the Office of Secretary of State when:

- (a) The child support debt is paid in full.
 - (b) The wrong person's social security number was used in filing the lien.
 - (e) The noncustodial parent has an order for retroactive child support and has paid according to the order since the initial adjudication.
 - (a) The child support debt is paid in full;
 - (b) The Notice of Lien was filed in error;
- (c) The noncustodial parent has filed bankruptcy;
 - (d) Documents indicate that the noncustodial parent's name is on the account strictly for fiduciary purposes, for example the management of the funds of an elderly parent.
