INTENDED ACTION: Revise Division 3 of the ADEM Administrative Code with the amendment of Rules 335-3-11A-.01 (General), and 335-3-11A-.02 (Designated Emission Standards).

SUBSTANCE OF PROPOSED ACTION:

Revisions to the Division 3 Code are being proposed to amend Rules 335-3-11A-.01 and 335-3-11A-.02 in Chapter 335-3-11A in order to incorporate by reference EPA changes to the Consolidated Federal Air Rule. This incorporation allows the EPA to delegate administrative enforcement of these regulations to ADEM. Chapter 335-3-11A is not considered as a part of the federally enforceable State Implementation Plan (SIP).
