Rule No. 560-X-10-. 07. Review of Medicaid Residents.

- (1) The Alabama Medicaid Agency or its designated agent will perform a review of Medicaid nursing home or ICF/MR facility residents' records to determine appropriateness of admission.
- (a) A nursing facility provider that fails to provide the required documentation or additional information for audit reviews as requested by the Alabama Medicaid Agency Long Term Care <u>Division or its designee Admissions/Records Unit</u> within ten working days from receipt of the certified letter shall be charged a penalty of one hundred dollars per recipient record per day for each calendar day after the established due date unless an extension request has been received and granted. The penalty will not be a reimbursable Medicaid cost. The <u>Long Term Care Division Associate Director of the Long Term Care Admissions/Records Unit may approve an extension for good cause.</u> Requests for an extension should be submitted in writing by the nursing facility Administrator to the <u>Long Term Care Division Associate Director of the Long Term Care Admissions/Records Unit with supporting documentation.</u>
