**RULE NO. & TITLE:** Rule 482-1-147-.08: Temporary Producer License.


**INTENDED ACTION:** Amend rule.

**SUBSTANCE OF PROPOSED ACTION:** The Commissioner of Insurance is proposing to amend the rule which sets forth the procedures for applying for a temporary producer license. The amendments change the fees consistent with recent changes to Section 27-4-2, Code of Alabama 1975.

**TIME, PLACE, MANNER OF PRESENTING VIEWS:** Interested persons may submit data, views, or arguments in writing at any time prior to August 5, 2015, to the Alabama Department of Insurance, Attention: Legal Division, Post Office Box 303351, Montgomery, Alabama 36130-3351, or orally by appearing at the public hearing, Suite 502, RSA Tower, 201 Monroe Street, Montgomery, Alabama, beginning at 10:00 AM, August 12, 2015.

1 **482-1-147-.08 Temporary Producer License.**

2 (1) Temporary License - Pending Examination.

3 (a) An individual otherwise qualified as an insurance  
4 producer except as to having taken and passed the written  
5 examination may apply for a temporary producer license  
6 according to the requirements set forth in this rule for the  
7 following lines of insurance:

8 1. Life.

9 2. Health.

10 3. Property.

11 4. Casualty.

12 5. Personal Lines.

13 (b) The applicant for a temporary producer license must  
14 be actively engaged in a prelicensing course for the line or  
15 lines of authority under the supervision of the appointing  
16 insurer or insurers. Evidence of enrollment in a course by an  
17 approved prelicense course provider will be required during  
18 the on-line licensing process.

19 (c) The applicant shall complete the Department's on-line  
20 licensing process to become licensed as a temporary producer  
21 for a particular line or lines of insurance. Instructions for

1 the on-line licensing process, as they may change from time to  
2 time, will be provided on the Department's Web page.

3 (d) A temporary producer license is valid for a maximum  
4 of six months, during which time the temporary licensee must  
5 complete the prelicensing education and examination  
6 requirements to convert the temporary license to a regular  
7 producer license.

8 (e)1. An individual may only have one temporary producer  
9 license for a particular line of authority in a lifetime,  
10 except when the prior license was canceled before expiration,  
11 in which case the remaining time may be applied to a  
12 subsequent temporary producer license.

13 2. The Department will rely on its license and  
14 appointment records to determine the length of time an  
15 individual held a temporary license in a line of authority for  
16 purposes of the six month limitation. The Department will not  
17 accept or act upon insurer representations that a producer's  
18 part appointment terminated earlier than as shown in the  
19 Department's records or that the producer did not earn  
20 commissions while appointed, or other similar claims which are  
21 not established or capable of being established in the  
22 Department's records.

1           (f)1. A temporary producer must be appointed by at least  
2 one insurer for each line of authority, but may be appointed  
3 to represent more than one insurer only by affiliated  
4 companies.

5           2. Each insurer using temporary producers shall have  
6 prospective temporary producer licensees sign a disclosure  
7 statement before application is made for the license, whether  
8 a new applicant or an applicant using the balance of an unused  
9 prior six-month license. The Department will provide a copy  
10 of the disclosure form on its Web site. A copy of the signed  
11 disclosure shall be provided to the applicant and the original  
12 signed disclosure shall be retained by the insurer and made  
13 available to the Department upon request.

14           3. An insurer shall terminate a temporary producer's  
15 appointment through the Department within five (5) business  
16 days after the date on which the temporary producer's  
17 employment with the insurer terminated, whether voluntarily by  
18 the producer's decision or involuntarily by the insurer's  
19 decision.

20           (g) The fees for a temporary producer license are the  
21 same as for an individual producer license as set forth below:

1           1. Application fee, Ala. Code § 27-4-2(a)(5)a.1.  
2 (1975) ..... ~~\$20.00~~ \$30.00

3           2. License fee, Ala. Code § 27-4-2(a)(5)a.2.  
4 (1975) ..... ~~\$40.00~~ \$50.00

5           3. Appointment fee, Ala. Code § 27-4-2(a)(6)  
6 (1975) ..... ~~\$30.00~~ \$40.00

7           (2) Temporary License - Death, Disability or Military  
8 Service of Licensed Producer (Type 2).

9           (a) An individual otherwise qualified as an insurance  
10 producer except as to having taken and passed the written  
11 examination may apply for a temporary producer license, herein  
12 referred to as a "Type 2" temporary license, for any line of  
13 insurance according to the requirements set forth in this rule  
14 under the following circumstances:

15           1. The individual is the surviving spouse or court-  
16 appointed personal representative of a licensed producer who  
17 dies or becomes mentally or physically disabled.

18           2. The individual is a member or employee of a business  
19 entity which is a licensed insurance producer, upon the death  
20 or disability of the licensed individual producer designated  
21 by the business entity to be responsible for the business

1 entity's compliance with all applicable laws, rules and  
2 regulations.

3       3. The individual is the designee of a licensed producer  
4 entering active service in the Armed Forces of the United  
5 States of America.

6       4. Another circumstance determined by the Commissioner  
7 on a case by case basis which best serves the public interest.

8       (b) The applicant shall submit or transmit the forms  
9 provided by the Department to become licensed as a Type 2  
10 temporary insurance producer under this paragraph.  
11 Instructions for the licensing process, as they may change  
12 from time to time, will be provided by the Department.

13       (c) The applicant must be sponsored by a licensed  
14 insurance producer or insurer who will assume responsibility  
15 for all acts of the Type 2 temporary producer.

16       (c) A Type 2 temporary producer license is valid for a  
17 period not to exceed six months, except a Type 2 temporary  
18 license issued under circumstances of disabling or confining  
19 illness or injury of the producer may be renewed for one  
20 additional six month term.

1 (d) The Type 2 temporary licensee may complete the  
2 prelicensing education and examination requirements and  
3 convert the Type 2 temporary license to an ordinary producer  
4 license.

5 (e) In the event an individual is unable to serve for the  
6 duration of the temporary license, a substitute individual may  
7 be licensed under the same requirements and conditions;  
8 however, the expiration date of the substitute licensee will  
9 be adjusted to conform to the time period indicated above in  
10 paragraph (c).

11 (f) A Type 2 temporary producer licensed under this  
12 paragraph may be appointed by more than one insurer.

13 (g) The fees for a Type 2 temporary producer license are  
14 the same as for an individual producer as set forth below:

- 15 1. Application fee, Ala. Code § 27-4-2(a)(5)a.1.  
16 (1975) ..... ~~\$20.00~~ \$30.00
- 17 2. License fee, Ala. Code § 27-4-2(a)(5)a.2.  
18 (1975) ..... ~~\$40.00~~ \$50.00
- 19 3. Appointment fee, Ala. Code § 27-4-2(a)(6)  
20 (1975) ..... ~~\$30.00~~ \$40.00



1           (3)(a) Upon successful completion of the required  
2 insurance producer examination and any criminal history record  
3 check required under Chapter 482-1-157, an unexpired temporary  
4 producer license under either paragraph (1) or (2) will be  
5 automatically converted to an individual insurance producer  
6 license for the same line of authority covered by the  
7 examination. No additional fees are required at that time and  
8 the new individual insurance producer license will be  
9 considered to have been first issued on the date of the  
10 conversion from the temporary license for purposes of  
11 determining renewal and continuing education requirements.

12           (b) If the temporary insurance producer license expires  
13 prior to successful completion of the required examination and  
14 any criminal history record check required under Chapter 482-  
15 1-157, the individual must complete the application process  
16 for individual insurance producer license to become licensed.
