## 80-10-2-.01 Purpose.

- (1) The purpose of this Chapter is to prevent the dissemination of sweet potato pests. The following rules in this Chapter govern the movement er, shipment, and certification within or into the State of Alabama of sweet potato seed, plants, table stock or vines., provided, that No sweet potato seed, sweet potato plants or vines within will be certified in the areas designated by the Commissioner as infested with the sweet potato weevil. The Commissioner may deem table stock grown in an infested area to be certified provided they have been trapped, inspected and found free of sweet potato weevil (Cylas formicaris) by the Commissioner or his representative. the areas which have been designated by the Commissioner as infested with the sweet potato weevil shall be eligible for certification.
- (2) The provisions herein shall not be construed to prohibit the possession or movement of noncertified sweet potato seed, plants, or vine cuttings for propagation purposes within the limits of a farm where such were produced.
