80-13-9-.06 Penalty for Violation.

All individuals required to comply with the requirements of this chapter shall be subject to the penalties contained in §8-16-123 of Code of Ala. 1975, as amended.

Any individual or entity found to be in violation of this chapter or any portion of Title 8, Chapter 16 of the Code of Ala. 1975, as amended, shall be subject to a fine of \$500.00 per occurrence for the first violation within a twelve (12) month period. Subsequent violations during the same twelve (12) month period shall result in a fine of twice the amount of the previous fine, not to exceed \$8,000.00 per twelve (12) month period.
