- (1) Overview of the Preliminary Certificate Through Exception in Educational Administration Approach. The Preliminary Certificate Through Exception in Educational Administration Approach allows employment in a public school system for individuals who have met all requirements for a Professional Leadership Certificate in an area of educational administration through the Certificate and Experience Reciprocity Option in Educational Administration as prescribed in Rule 290-3-2-.22(d), except the administrative experience requirement, and also have verified three full years of full time, acceptable professional educational experience in a P-12 setting, which includes at least one full year of full time P-12 teaching experience. A public school superintendent may request a Preliminary Certificate Through Exception in Educational Administration to employ an applicant full-time as an assistant superintendent, principal, assistant principal, career and technical administrator, or assistant career and technical administrator. The chairperson/president of a public school system board may request a Preliminary Certificate Through Exception in Educational Administration to employ an applicant fulltime as a superintendent. Complete applications for the Preliminary Certificate Through Exception in Educational Administration approach must be received in the Office no later than October 1 of the scholastic year for which they are requested.
- (a) Recommendations may <u>only</u> be made for applicants who meet all requirements for the first Preliminary Certificate Through Exception in Educational Administration as prescribed in Rule 290-3-2-.16(5)(a).
- (b) An applicant using the Preliminary Certificate Through Exception in Educational Administration approach must meet the basic requirements in Rule 290-3-2-.22(a) and degree requirements in 290-3-2-.22(b).

- (1) Overview of the Preliminary Certificate Through Exception in Reading. During a No Child Left Behind/Elementary and Secondary Education Act monitoring visit on February 2-3, 2010, the U.S. Department of Education cited the Alabama Department of Education for indicating that teachers who are highly qualified (HQ) to teach reading at the early childhood or elementary level were also HQ to teach struggling readers above the grade level of their Professional Educator Certificate. As a result, the Department was charged with creating an option for approximately 400 teachers who met the criteria in Rule 290-3-2-.16(1)(a)1. to obtain certification in reading above the grade level of their Professional Educator Certificate. The Preliminary Certificate Through Exception in Reading approach will result in a Professional Educator Certificate in Reading (general education or special education) grades P-12.
- (a) Only Alabama public school superintendents may use Supplement ADR to recommend that the State Superintendent of Education consider an exception to issue a Preliminary Certificate Through Exception in Reading.
- 1. Recommendations may only be made for public school teachers who meet <u>one</u> of the following criteria:
- (i) Hold a valid Early Childhood Education (grades P-3) or Early Childhood Special Education (grades P-3) Professional Educator Certificate and who taught reading in an Alabama public school system during the 2009-2010 scholastic year to students above grade 3.
- (ii) Hold a valid Collaborative Teacher (grades K-6), Elementary Multiple Abilities (grades K-6), or Elementary Education (grades K-6 or 1-6) Professional Educator Certificate and who taught reading in an Alabama public school system during the 2009-2010 scholastic year to students above grade 6.
- (iii) Hold a valid Elementary Education (grades 1-9) Professional Educator Certificate and who taught reading in an Alabama public school system during the 2009-2010 scholastic year to students above grade 6.
- (b) A Preliminary Certificate Through Exception in Reading allows up to two years of employment. The applicant must complete all requirements of the Preliminary Certificate Through Exception in Reading approach within the 2010-2011 and 2011-2012 scholastic years.
- (c) An individual must hold a valid certificate for all teaching fields and instructional support areas and at the grade level to which he or she is assigned.
- (d) The superintendent is required to monitor the applicant's compliance with the requirements of the Preliminary Certificate Through Exception in Reading approach.
- (e) Additional information about the Preliminary Certificate Through Exception in Reading approach can be found on Supplement ADR.

(2) Limitations on Issuance. An individual may not be employed for more than three scholastic years on the basis of holding an Alternative Baccalaureate-Level Certificate, a Career and Technical Alternative Baccalaureate-Level Certificate, a Preliminary Certificate Through Exception, a Special Alternative Certificate, an alternative-approach certificate issued by another state or issuing authority, or any combination thereof. - (a) Issuance of the <u>first Preliminary Certificate Through Exception in Reading valid</u> July 1, 2010 through June 30, 2011 requires:
- 1. A recommendation on Supplement ADR from a superintendent who wishes to employ the applicant full-time in the area and grade level of the Professional Educator Certificate or Professional Leadership Certificate held and in reading.
- 2. Verification that the applicant held during the 2009-2010 scholastic year and holds during the 2010-2011 scholastic year a valid Professional Educator Certificate in one of the following:
 - (i) Early Childhood Education (P-3).
 - (ii) Early Childhood Special Education (P-3).
 - (iii) Collaborative Teacher (K-6).
 - (iv) Elementary Multiple Abilities (K-6).
 - (v) Elementary Education (K-6, 1-6, or 1-9).
- 3. Verification that Highly Qualified Teacher Status has been obtained or will be obtained by the applicant in the area of the certificate in Rule 290-3-2-.16(4)(a)2. on or prior to May 1, 2011.

- (c) Verification of a <u>current</u> passing score attained on the prescribed Praxis II subject assessment of the Alabama Prospective Teacher Testing Program (APTTP). This requirement becomes effective upon adoption by the Alabama State Board of Education of a newly prescribed subject assessment. This requirement also becomes effective upon adoption by the Alabama State Board of Education of an increased minimum passing score on an existing prescribed subject assessment. The date by which these requirements must be met will be prescribed by the Alabama Department of Education. Additional information is in Rule 290-3-2-.01(6).
- (d) Verification that Highly Qualified Teacher Status in reading was obtained prior to September 1, 2012.
 - (e) Completion of all requirements on Supplement ADR.
- (f) Submission of an application for certification on Form APP. The complete application must be received in the Office no later than October 1, 2012. An individual who does not apply by this date may forfeit the right to seek a Professional Educator Certificate in Reading through this approach.
