290-3-2-.25 <u>Career and Technical Education Additional Teaching Field Approach</u>
<u>Based on a Professional Educator Certificate, Experience, and an Occupational Proficiency Assessment.</u>

(1) Overview.

- (a) An applicant who holds a valid Professional Educator Certificate in a teaching field as prescribed in Rule 290-3-2-.03(2) may be able to add a Class B certificate in a selected technical education program area or health science if the individual meets the experience and occupational proficiency assessment (test scores, license, or credential) requirements.
- (b) The Career and Technical Additional Teaching Field approach is available only in the subjects and grade levels on Form CBP in effect on the date the application is received in the Office.

(2) Limitations on Issuance.

- (a) The Career and Technical Education Additional Teaching Field approach is not available to an individual who holds only a Professional Educator Certificate in an area of instructional support or a Professional Leadership Certificate.
- (b) The Career and Technical Education Additional Teaching Field approach is not available to an individual who holds only an Alternative Baccalaureate-Level, Career and Technical Alternative Baccalaureate-Level, Special Alternative, Preliminary, Career and Technical Specialty Area and/or Level and/or Type, Speech-Language Pathology Assistant, Junior Reserve Officer Training Corps, Interim, Emergency, or Career and Technical Education Temporary Certificate.

(3) Requirements.

- (a) An applicant using this approach must verify two full scholastic years of full-time classroom teaching experience within a P-12 setting. Partial years cannot be combined to meet this requirement. Experience must be verified on Supplement EXP. Experience must be completed prior to September 1 in order for the certificate to begin validity July 1 of the same scholastic year.
- (b) An applicant using this approach must verify a passing score on the appropriate Alabama Department of Education approved occupational proficiency assessment (test scores, license, or credential). The occupational proficiency assessment requirement must be completed by December 31 in order for the certificate to begin validity July 1 of the same scholastic year.

- (4) Application for the Professional Educator Certificate. The appropriate Class B Professional Educator Certificate may be issued through this approach when the applicant has met <u>all</u> of the following requirements:

- (b) Supplement EXP documenting two full scholastic years of full-time classroom teaching experience as prescribed in Rule 290-3-2-.25(3)(a).
- (c) A passing score on the appropriate Alabama Department of Education approved occupational proficiency assessment (test scores, license, or credential) as prescribed in Rule 290-3-2-.25(3)(b).
- (d) Submission of Form CBP and completion of all requirements as prescribed on the form.
- (e) The Form CBP must be received in the Office no later than December 31 in order for the certificate to begin validity July 1 of the same scholastic year.
