- Match permits. Match, contest, and/or exhibition permits will be determined and issued at the discretion of the Commission's executive director upon receipt, review, and approval of all materials required in the Show Date Request.
- Matchmaker licensing will be determined at the discretion of the sanctioning Commissions.
- A match permit fee will be calculated by the Commission. The match permit fee shall be calculated at five percent (5%) of the gross proceeds from ticket sales to the boxing match, contest, or exhibition, exclusive of any federal
