Chapter 660-2-2 FAMILY ASSISTANCE PROGRAM

660-2-2-.41 Unauthorized Electronic Benefits Transfer (EBT) Transactions

(1) Legal Basis

Federal law requires states to prevent assistance provided under the FA Program from being used in any EBT transaction in liquor stores, gambling establishments, and strip clubs. Use of the card in those locations is referred to as unauthorized EBT transactions. Actions taken to prevent unauthorized transactions include client education about the spending restriction and a financial penalty for noncompliance without good cause.

(2) Penalty for Noncompliance

For each month of noncompliance, the grant amount will be reduced by 50% of the payment standard for the assistance unit size.

(3) Good Cause for Unauthorized EBT Transactions

- (a) Lack of transportation or lack of free transportation to non-prohibited locations.
 - (b) Emergencies
- (c) Lack of or limited access to non-prohibited locations in the community/area of residence.

(d) Other circumstance pursuant to Department program operating guidelines.

(4) Definitions

- (a) Unauthorized EBT Transaction- Use of an EBT card to withdraw FA benefits or process a payment for merchandise or a service from an ATM or POS device physically located in a liquor store, gambling establishment or strip club.
- (b) **Liquor store** Any establishment selling exclusively or primarily intoxicating liquor.
- (c) **Gambling establishment** Any establishment offering casino, gambling or gaming activities as the primary purpose of the establishment.
- (d) **Strip Club** Any retail establishment providing adultoriented entertainment in which performers disrobe or perform in an unclothed state for entertainment.
