Repeal an existing rule

SUBSTANCE OF PROPOSED ACTION: The International Registration Plan was adopted by Alabama in 1979, as provided by Section 32-6-56, Code of Alabama 1975. This statute specifically provides that if the provisions of the Plan differ from provisions prescribed by the Code or any rules or regulations, the Plan shall prevail. In 2001, the International Registration Plan document was adopted by reference as a Department of Revenue Administrative rule. Consequently, this rule should be repealed.
