## **RULE NO. & TITLE:**

810-8-1-.29

Deposits in Lieu of Surety Bonds

**INTENDED ACTION:** 

Amend an existing rule

<u>SUBSTANCE OF PROPOSED ACTION:</u> The Department proposes to amend the above rule to change the name of the division where a deposit of a US Government bond is sent in lieu of a surety bond from the Natural Resources and License Tax Division to the Sales, Use & Business Tax Division.

Sales Records of a Licensed Distributor

**INTENDED ACTION:** 

Amend an existing rule

**SUBSTANCE OF PROPOSED ACTION:** The Department proposes to amend the above rule to delete the reference to \$.04 exempt sales for motor fuel that should have been amended in 1992. Effective June 1, 1992, the law was changed and cities and counties were allowed the full exemption of \$.17 per gallon instead of \$.04 per gallon of motor fuel.

Motor Fuel Tax Regulation - Stated and Uniform Policy Pertaining to the Exemption of Certain Taxpayers from State Motor Fuel

**INTENDED ACTION:** 

Amend an existing rule

<u>SUBSTANCE OF PROPOSED ACTION:</u> The Department proposes to amend the above rule to provide a procedure where a taxpayer can compute the state sales tax due when applying for a refund of motor fuel excise tax when the fuel is used off-road in designated off-road equipment. The sales tax will be netted against the motor fuel excise tax and the net amount refunded to the taxpayer. The Department also proposes to amend the title of the rule.
