NOTICE OF INTENDED ACTION

RULE NO. & TITLE:

810-5-1-.225 Handicapped Parking Privileges-Evidence of Qualifications and Enforcement Procedures

INTENDED ACTION: Amend an existing rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to amend the above rule to remove language already stated in the Code of Federal Regulations and in the Code of Alabama 1975. In addition, the department proposes to remove the fee for removable windshield placards and amend the title of the rule.

RULE NO. & TITLE:

810-5-1-.442 Vehicles which are Specifically Exempt from Apportioned Registration

INTENDED ACTION: Repeal and New

SUBSTANCE OF PROPOSED ACTION: The department proposes to repeal the above rule in its entirety and insert new language which will provide limitations on the use of farm and forestry products license plates. In addition, the rule title will also be changed.

RULE NO. & TITLE:

810-5-75-.14 Title Procedure-Transfer of Title for a Vehicle obtained by Divorce or Court Order

INTENDED ACTION: Repeal and New

SUBSTANCE OF PROPOSED ACTION: The department proposes to repeal the above rule in its entirety and insert new language which will clarify title procedures involving an involuntary transfer by operation of law. In addition, the rule title will also be changed.

RULE NO. & TITLE:

810-5-75-.17 Title Procedure-Repossessed (1975 and Later Model) Vehicle that has been Titled in Another State, First Title in Alabama

INTENDED ACTION: Repeal and New

SUBSTANCE OF PROPOSED ACTION: The department proposes to repeal the above rule in its entirety due to the fact that it conflicts with Section 32-8-6, Code of Alabama 1975. In addition, new language will be added which will reflect current title procedures for repossessed motor vehicles and the rule title will be also be changed.

RULE NO. & TITLE:

810-5-75-.13	Title Procedure-Transfer of title for a Vehicle Obtained by a Sheriff's or Court Sale
810-5-75-.19	Title Procedure-Repossessed (1975 and Later Model) Vehicle that has been Titled in Alabama with Lienholder (Repossessor) Properly Shown on Title
810-5-75-.32	Title Procedure-Transfer of Title for a Vehicle in Bankruptcy
810-5-75-.33	Title Procedure-Transfer of Title when a Vehicle is Repossessed by a Lienholder Whose Lien has not been Recorded

INTENDED ACTION: Repeal the above rules

SUBSTANCE OF PROPOSED ACTION: The department proposes to repeal the above rules due to the fact that they are in conflict with Section 32-8-6, Code of Alabama 1975 and the subject matter is addressed in Administrative Rules 810-5-75-.14 or 810-5-75-.17.


