NOTICE OF INTENDED ACTION

RULE NO. & TITLE:

810-5-1-.237 Procedures for Issuing Provisional Registration Reinstatements

INTENDED ACTION: Amend the above rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to amend the above rule due to law changes which allow the Administrative Office of Courts and county circuit clerks to process MLI Registration Reinstatements and to remove "Provisional" language from rule to be more consistent with the language of the law in order to promote uniformity when issuing registration reinstatements. In addition, the rule title will also be amended.

RULE NO. & TITLE:

810-5-1-.240 Permanent Trailer License Plates

INTENDED ACTION: Amend the above rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to amend the above rule to clarify that trailers towed by motorcycles are considered utility trailers.

RULE NO. & TITLE:

810-5-8-.04 Registration Denial–Mandatory Liability Insurance Law

INTENDED ACTION: Amend the above rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to amend the above rule to include the provision that registration will be denied for registrant refusing to provide driver's license number, etc. as required by Section 32-7A-10, Code of Alabama 1975.

RULE NO. & TITLE:

810-5-8-.06 Affirmation of Motor Vehicle Liability Insurance

INTENDED ACTION: Amend the above rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to amend the above rule to include reference to applications for apportioned license plates as appropriate so that Rule 810-5-8-.09 may be repealed. In addition, the rule is being amended to remove reference to manufacturer license plates being issued by the Department's Taxpayer Service Center personnel as these plates are now issued by the county licensing officials.

RULE NO. & TITLE:

810-5-8-.08 Refunds of Reinstatement Fees Generally; Refund Request Forms; Procedures to Appeal Denial of Requests for Refund of Reinstatement Fees

INTENDED ACTION: Amend the above rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to amend the above rule to include language from the law stating that refunds of MLI reinstatement fees are not to include the fees retained by any officials authorized to collect MLI reinstatement fees, as provided in Section 32-7A-9, Code of Alabama 1975. In addition, the rule title will also be amended.

RULE NO. & TITLE:

810-5-8-.10 Random Sampling, Questionnaire Form, Notice of Suspension, and Procedures to be Followed

INTENDED ACTION: Amend the above rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to amend the above rule to remove incorrect references to form numbers. In addition, the rule title will also be amended.


