NOTICE OF INTENDED ACTION

RULE NO. & TITLE:

810-5-1-.232 The Issuance of Distinctive License Plates or Tags to United States Retired Military Persons

INTENDED ACTION: Amend an existing rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to amend the above rule to reflect changes to Sections 32-6-291 and 32-6-292 as well as changes to the Service members Civil Relief Act. In addition, the department also proposes to amend the title of the rule.

RULE NO. & TITLE:

810-5-1-.468 Refunds/Credits of Apportioned Registration Fees

INTENDED ACTION: Amend an existing rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to amend the above rule in order to consolidate rules that include provisions regarding motor vehicle registration fee refunds.

RULE NO. & TITLE:

810-14-1-.23 Refunds of Motor Vehicle Registration Fees

INTENDED ACTION: Repeal an existing rule

SUBSTANCE OF PROPOSED ACTION: The purpose of the above action is to consolidate the existing language of the above rule into proposed amended Rule 810-5-1-.468; therefore, the department proposes to repeal Rule 810-14-1-.23.

RULE NO. & TITLE:

810-5-1-.220 Medal of Honor Winners and Prisoners of War Distinctive Tags,
Replacement of

INTENDED ACTION: Repeal an existing rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to repeal the above rule due to provisions of 40-12-265(b), Code of Alabama 1975, which provides for a replacement plate to be issued when the original plate issued is illegible.

RULE NO. & TITLE:

810-5-1-.483.01 Exclusion – Utility Trailers

INTENDED ACTION: Repeal an existing rule

SUBSTANCE OF PROPOSED ACTION: The department proposes to repeal the above rule due to the provisions of Section 32-8-31(11), which provides that utility trailers are exempt from certificate of title provisions.


