**INTENDED ACTION:** Revise Division 3 of the ADEM Administrative Code with the amendment of Rules 335-3-8-.16 (CAIR NOx Annual Trading Program), 335-3-8-.17 (CAIR Designated Representative for CAIR NOx Sources), 335-3-8-.18 (CAIR Permits), 335-3-8-.21 (CAIR NOx Allowance Tracking System), 335-3-8-.23 (CAIR Monitoring and Reporting), 335-3-8-.25 (CAIR NOx Ozone Season Trading Program), 335-5-8-.30 (CAIR NOx Ozone Season Allowance Tracking System), and 335-5-8-.32 (CAIR NOx Ozone Season Monitoring and Reporting).

## SUBSTANCE OF PROPOSED ACTION:

Revisions to the Division 3 Code are being proposed to amend Rules 335-3-8-.16, 335-3-8-.17, 335-3-8-.18, 335-3-8-.21, 335-3-8-.23, 335-3-8-.25, 335-3-8-.30, and 335-3-8-.32 in order to incorporate provisions for the control of nitrogen oxide emissions from specified categories of stationary sources. These revisions are necessary to incorporate EPA's changes to the Clean Air Interstate Rule. This adoption allows the EPA to delegate administrative enforcement of these regulations to ADEM. Chapter 335-3-8 is considered a part of the federally enforceable State Implementation Plan (SIP). As such, revisions to this Chapter/Rule are proposed to be incorporated into Alabama's SIP.
