#### **INTENDED ACTION:**

Revise Division 7 of the ADEM Administrative Code.

# SUBSTANCE OR PROPOSED ACTION:

Revisions to the Division 7 Code are being proposed to amend Rule 335-7-2-.03 to make the Nitrate requirements the same as USEPA, separate the Organic Chemical Standards and Monitoring Requirements into different sections to allow for easier reference and correct grammatical errors. Rule 335-7-2-.04 was amended to delete Volatile Synthetic Organic Chemicals and Disinfection Byproducts. Rule 335-7-2-.05 was created to keep the Organic Chemical Standards and Monitoring requirements in order. Rule 335-7-2-.06, 335-7-2-.07, 335-7-2-.08, 335-7-2-.09, 335-7-2-.10, 335-7-2-.18, 335-7-2-.19 and 335-7-2-.20 are being amended for renumbering of sections and rewording to make the sections easier to read. Rule 335-7-2-.11 was added to separate the Stage 1 Disinfection Byproducts from the Organic Chemical Standards and Monitoring Requirements for easier reference. Rules 335-7-2-.12, 335-7-2-.13, 335-7-2-.14, 335-7-2-.15 and 335-7-2-.16 were added to

comply with USEPA's Stage 2 Disinfection/Disinfection Byproduct Rule. Rule 335-7-2-.17 was added to comply with USEPA's Long Term 2 Enhanced Surface Water Treatment Rule. Rule 335-7-2-.21 was renumbered and modified to comply with USEPA's Long term 2 Enhanced Surface Water Treatment Rule.
