INTENDED ACTION:

Revise Division 7 of the ADEM Administrative Code.

SUBSTANCE OR PROPOSED ACTION:


Revisions to the Division 7 Code are being proposed to amend Rule 335-7-6-.01, 335-7-6-.11 and 335-7-6-.14 to comply with USEPA's Long Term 1 and 2 Enhanced Surface Water Treatment Rules. Rules 335-7-6-.03, 335-7-6-.07, 335-7-6-.08, and 335-7-6-.14 were amended to correct references and grammatical errors. Rules 335-7-6-.19, 335-7-6-.20, 335-7-6-.21, 335-7-6-.22, 335-7-6-.23, 335-7-6-.24, 335-7-6-.25 and 335-7-6-.26 were added to comply with USEPA's Stage 2 Disinfectant/Disinfection Byproduct Rule. Rule 335-7-6-.09 was amended to remove an operator certification regulation which is being added to the Division 10 Code.
