**SUBSTANCE OF PROPOSED ACTION:** The department proposes to amend the above rule to comply with the provisions of Act 2010-748.

**RULE NO. & TITLE:**

810-5-75-.61 Schedule of Fees and Commissions – Remittance of Fees by Personal Check or Company Checks of Designated Agents

**INTENDED ACTION:** Amend an existing rule

**SUBSTANCE OF PROPOSED ACTION:** The department proposes to amend the above rule to clarify the process for the payment of fees required under Section 32-8-6, Code of Alabama 1975.

**RULE NO. & TITLE:**

810-5-1-.211 Motor Vehicle Registration Delinquency Penalty and Interest Charges

**INTENDED ACTION:** Amend an existing rule

**SUBSTANCE OF PROPOSED ACTION:** The department proposes to amend the above rule to provide that the collection of a registration law penalty by a license plate issuing official may be reviewed by a court of competent jurisdiction in order to seek a refund of the penalty or interest charges.

**RULE NO. & TITLE:**

810-5-1-.215 Vintage Vehicle License Plates; Issuance of; Use of; Transferring; Other Provisions

**INTENDED ACTION:** Amend the above rule

**SUBSTANCE OF PROPOSED ACTION:** The department proposes to amend the above rule to include the provisions of Administrative Rule 810-5-1-.242, which is being repealed.

**RULE NO. & TITLE:**

810-5-1-.242 Registration Procedures for Vehicles Registered Under Section 40-12-297

**INTENDED ACTION:** Repeal the above rule

**SUBSTANCE OF PROPOSED ACTION:** The department proposes to repeal the above rule due to the fact the substance of the rule is being consolidated into proposed amended Rule 810-5-1-.215.


